Treasurer's Report (*Tara Moe*) **Activity Highlights**

Tara presented the March 2021 Financial Report; light activity in March; income included \$120 Membership, \$195 Corporate Matching, \$1,200 Senior Yard Signs, \$175 Practice Tests, and \$130 Angel donations; expenditures finally cleared out the carryover Angel donations from last year; a non-signer, Bhavna Patel, reviewed the February and March bank statements

MOTION 1 Wendy Cummins moved to accept the candidates proposed by the Nominating Committee and to refer to the proposed candidates as "The Slate of Nominees." Motion was seconded. Voice vote. Motion passes.

Only one candidate is nominated for each office, and there were no nominations from the floor, so the Slate of Nominees is elected. Karissa will email a signed copy of the Nominating Report to the co-Presidents.

The designated check signers will be Kim Wilkinson, Birgit Aarrestad, Tara Moe, and Kristen Allen-Bentsen.

Speaker

The speaker, IHS Principal Andrea McCormick, was introduced.

Principal McCormick reported that:

- Graduation: she has a graduation meeting this afternoon but preliminary comments are that IHS is looking at
 expanding the portion of T-Mobile Park that it has rented to accommodate social distancing requirements for
 more attendees; IHS is trying to get to place where more guests are allowed, but worst case will be three guests
 per graduate (family group of 4); the event also will be live streamed so that people who cannot attend in person
 can watch; there will not be a graduation rehearsal, but the students will get instructions by video
- Senior events
 - Senior recognition event will be virtual
 - o Cap and gown pick up is scheduled for May 19
 - Senior Sunrise will be an in-person event, but the time may be pushed back to later in the morning; the
 point is to get the seniors together for breakfast and to watch the senior slide show; the event will be on a
 Wednesday and the location(s) at the school will depend on what COVID-19 reopening Phase we are in;
 the teacher tunnel will follow the senior sunrise; may be able to do the tunnel as a walk-through because
 the teachers and many students will be vaccinated

- Hybrid return has been smooth from an administrative perspective; because students will be sitting in same lunch
 seats for the whole year IHS was flexible about seating for the first couple of days; attendance is slightly lower than
 expected; some families have said they are waiting until their student is vaccinated so the number of students on
 campus is expected to grow
- Staff Layoffs –School Board meetings are recorded so you can listen to the discussion about this at the April 13 School Board meeting; due to decline in enrollment and higher expenses, ISD has to make some budget cuts for next year and the School Board has approved a plan to cut about 300 staff; there are 28 IHS teacher positions on the RIF list; ISD hasn't gone through this process in many years, but basically the RIFs will happen by seniority; to the extent that RIFs create openings, higher-seniority teachers will have the chance to move to fill openings at other schools; some teachers may be recalled if they have endorsements in hard-to-fill areas
- Outreach to families who have chosen to stay 100 percent remote Alaina Sivadasan, ISD Executive Director of Equity, currently is surveying families that have chosen to stay remote, ISD hopes understanding the reasons for the choice will help in directing future outreach to these families and students

PTSA Individual Awards

(Carla Geraci) Each year our PTSA has the opportunity to recognize outstanding volunteers with the Golden Acorn and Outstanding Advocate Awards. The committee this year was comprised of Chair Carla Geraci and members Wendy Cummins and Shamitha Sridharan.

- The Golden Acorn Award is a state PTA award presented to a volunteer in recognition of his/her dedication and service to children and youth. This year, the Golden Acorn Award goes to Nicole Garcia.
- The Outstanding Advocate Award is a state PTA award presented to a volunteer in recognition of his/her advocacy and commitment in helping to create strong policies relating to the health, welfare, safety and education of children and youth. This year, the Outstanding Advocate Award goes to Wendy Marucheck.

Business

Votes to Amend Senior Events Budget

Co-V.P. of Events Kristen Allen-Bentsen noted that COVID-19 has impacted the way senior events will be handled this year. Certain traditional in-person events are being held online, and other events need to be supported differently. The 5K PE runs, the 8th grade information night, and the college night are not being held in person this year. The Senior Breakfast will be held in person, but the expenses likely will be higher because the PTSA will not be able to solicit food donations and will need to purchase prepackaged food. And instead of the all-night grad party funded by ticket sales, the PTSA will be hosting an outdoor picnic-type celebration at Veterans Memorial Field. In light of these circumstances, it is desirable to make certain changes to the Events budget.

MOTION 2 Kristen moved to reallocate the following line items: (1) \$200 from 5K runs (2), (2) \$100 from 8th Grade Events, and (3) \$400 from College Night, zeroing out those line items and increasing the Senior Breakfast line item by \$700. Motion was seconded. Voice vote. Motion passes.

MOTION 3 Kristen moved to reallocate \$3,500 from the Senior Farewell line item to the Other Senior Events line item, zeroing out the Senior Farewell line item, and to increase the Other Senior Events line item by and additional \$4,000, for a total increase to Other Senior Events of \$7,000. Motion was seconded. Voice vote. Motion passes.

Communications (Wendy Marucheck and Satnam Purewal) **Social Media**

We have increased our followers on our social media channels:

- <u>Facebook</u> 710 followers (695 last month); last month posts reached between 70-500 viewers; back to school posts, graduation, spotlights was the most popular; we also have 180 followers on our senior only page, and its reach is larger than its followers
- <u>Instagram</u> 543 followers (526 last month); last month posts reached up to 280 viewers; most popular posts were spotlights

• <u>Twitter</u> 84 followers (80 last month); posts reached up to 220 viewers; volunteer requests were the most popular
