Treasurer's Report *(Tara Moe)*

Activity Highlights

Tara presented the April 2021 Financial Report; light activity in April; expenses included \$500 for Student Academic Fund, \$1,500 for Teacher Classroom Fund, \$3,324 for Senior Yard Signs, \$1,797 for Staff Appreciation Week, and \$750 for our annual donation to the Issaquah Schools Foundation "Nourish Every Mind" event; a non-signer, Bhavna Patel, reviewed the April bank statements

Our Financial Review will take place in July. Committee is Heather Bratton, Wendy Maruchek, and Bhavna Patel.

Business

Approval of Preliminary 2021-2022 Budget

Tara presented the proposed Preliminary Budget for 2021-2022. Budget committee has compiled the proposed budget for next year based on input from board members and committee chairs about anticipated expenses for the rest of this year, and any increases or decreases that should be made for next year based on the pre-COVID level of expenditures; income projection is based on 1,000 members (up from approximately 840 this year), and \$25,000 from Pass the Hat

MOTION 1 Tara moved to approve the 2020-2021 Preliminary Budget as presented. Motion was seconded. Voice vote. Motion passes.

Tara thanked the members of the Budget Committee: Tara Moe, Kaiyu Yan, Wendy Cummins, Sathya Kannan, Lisa Small, Heidi Fuhs, Kristen Allen-Bentsen, and Natasha De Los Reyes.

Speaker

The speaker, IHS Principal Andrea McCormick, was introduced.

Principal McCormick reported that:

- It should be clarified that the possible return to four-day-a-week attendance depends on meeting a threshold number of cases per day—fewer than 200 cases for five days in a row; we’re approaching that number and may hit it by the end of this week; that means that four-day-per-week school would start June 1 at the earliest; at that level, desks will be three feet apart; lunches will remain the same but students will have to repick seats
- Costco/ISD vaccine clinic will take place at IHS on Thursday and Friday (“B” schedule days); June dates will be Tuesday (June 8) and Wednesday (June 9) (“A” schedule days); the June clinic won’t impact finals (more details in eNews to come soon); many students are waiting until they are fully vaccinated to return in person
- Senior information has gone out; still waiting for confirmation on seating arrangements from T-Mobile; IHS has prepared based on the maximum restrictions, but parents should be aware that restrictions may loosen; blankets have been ordered for senior breakfast on June 9, seniors will be seated on the grass to watch the slide show and exit through the traditional teacher tunnel
- Summer school eNews will come out in the next day or so; will be in-person five days per week
- School Board has announced that ISD intends to open fully, five days a week in the Fall; masking and other health protocols will depend on then-current public health guidance
- ISD has not decided whether it will require students to be vaccinated to return to school in the Fall
- City of Issaquah is hosting listening sessions to gather community input on the topic of school resource officers; session for IHS specifically will be tomorrow night; 5:30pm for parents and 7:30pm for students
- Boundaries have not been finalized yet for HS feeder patterns because of uncertainty regarding the opening date for comprehensive high school #4
