Treasurer's Report *(Tara Moe)*

- The August 2021 Financial Report was reviewed.
 - Income
 - o \$8,475 from Memberships
 - o \$17,825 from Pass The Hat
 - o \$6,885 from Angel Program donations
 - o \$2,700 ACT/SAT Mock Tests
- The annual Financial Review took place on July 22, 2021. Thank you Wendy Maruchek, Heather Bratton, and Bhavana Patel. Everything looked good. Suggestion to request the membership roster at the end of the year from Membership Director.

- o **MOTION 1** Wendy Cummins moved to approve the Financial Review as presented. Motion was seconded. Voice vote. Motion passes.
- The proposed 2021-22 budget was reviewed. Suggest decreasing Pass the Hat income, increasing Salmon Days Parking income, and decreasing Council Fees due to no longer having to pay for Survey Monkey.
 - o **MOTION 2** Tara Moe moved to approve the 2021-22 budget as presented.. Motion was seconded. Voice vote. Motion passes.
- A non-signer, Bhavana Patel, reviewed the June bank statement.
- A non-signer, Kaiyu Yan, reviewed the July and August bank statements.

- The 2021-22 Mission Statement and Goals were reviewed and approved by membership (see attached motion).
 - o **MOTION 3** Wendy Maruchek moved to approve the 2021-22 Mission and Goals as presented.. Motion was seconded. Voice vote. Motion passes.
- The 2021-22 Standing Rules were reviewed.
 - o **MOTION 4** Chanju Lee moved to approve the Standing Rules as presented.. Motion was seconded. Voice vote. Motion passes.
- Molly Dorr was presented as the nominee for co-VP of Communications.
 - o **MOTION 5** Kim Wilkinson moved to elect Molly Dorr as co-VP of Communication for the 2021-22 school year. Motion was seconded. Voice vote. Motion passes.

Speaker

IHS Principal, Erin Connolly, was introduced.

Erin Connolly reported that:

- Students have been doing a great job masking during the school day.
- IHS has had to close bathrooms due to TikTok trend, Devious Licks.
 - o There are still sinks available for handwashing.
- Masking at football games. Update sent out via eNews.
 - o Last week: email reminders, reminder at the gate, announcements during the game, school administrators addressing violators.
 - o This week: In addition to last week's expectations, adding additional administrators to enforce, working with ASB, and Band leaders to help.
 - o Will be asking unmasked individuals to leave.
- Nest
 - o Right now focusing on beginning-of-school business
 - o First choice day on 9/29 when students will be able to visit teachers for support
 - o October will introduce software to sign up which will greatly increase Nest options for students
- Lunch - In addition to the commons, stadium and upper gym are covered and available. Will set up canopies for additional outside, covered seating options.
- When absent, teachers are posting assignments on Canvas. Extended absences due to Covid, the school will reach out to offer additional support.
- Using the DoH guidance re: Covid practices.
- Doors open at 7:45 so that students do not congregate in the commons since it's safer for them to be outside. Also, it aligns with staffing.
- Pick up and drop off is very congested, but there are not many alternatives available to address it at this point.
- Homecoming will not take place this year.
- Graduation date has not yet been set.

IHS ASB Director, Kurtis Evans, was introduced.

Kurtis Evans reported that:

- ASB is focused on the entire student experience.
- ASB is the Associated Student Body. Distribute public funds.
- Information about clubs and activities can be found on the IHS website.

- Large events are planned to be outdoors as much as possible. Planning multiple options for events as things change.
- Student Senate Meeting to review new club requests. There is a new Interest Proposal form under Activities on the IHS website.
- Homecoming Week 10/19-10/22. No dance, but will have robust activities throughout the week and looking for formal event space to still celebrate.
- Clubs Fair will be 10/6.
- ASB chooses themes for dances. Sporting event themes are chosen by the ref group (student-led group where membership is passed down year to year).
- Clubs will begin meeting after 10/5 (after training and Student Senate Meeting).
